

RESOLUTION 2020 229

BEFORE THE BOARD OF COMMISSIONERS OF BENTON COUNTY, WASHINGTON

IN THE MATTER OF ESTABLISHING A RISK MANAGER SALARY ON THE MANAGERS AND ADMINISTRATORS SALARY SCHEDULE, CHANGING THE PUBLIC WORKS MANAGER TITLE TO DIRECTOR OF OPERATIONS AND CAPITAL ASSETS, AND CHANGING THE TITLE OF THE JAIL COMMANDER TO CHIEF OF CORRECTIONS.

WHEREAS, as part of the job titles, job descriptions, and budget titles administrative clean-up project, the need to establish the Risk Manager salary on the Managers and Administrators salary schedule has come up; and

WHEREAS, change the title of the Public Works Manager to the Director of Operations and Capital Assets; and

WHEREAS, change the title of the Jail Commander to the Chief of Corrections; and

WHEREAS, job descriptions have also been updated for the Director of Operations and Capital Assets and the Chief of Corrections; **NOW, THEREFORE**,

BE IT RESOLVED, that the Board of Benton County Commissioners hereby approve the placement of the Risk Manager position on the Benton County Managers and Administrators salary schedule at a grade 6; and

BE IT RESOLVED, that the Board of Benton County Commissioners hereby approve the title change of the Public Works Manager to the Director of Operations and Capital Assets; and


BE IT RESOLVED, that the Board of Benton County Commissioners hereby approve title change of the Jail Commander to the Chief of Corrections; and

BE IT RESOLVED, that the Board of Benton County Commissioners hereby adopt the revised and attached 2020 Managers and Administrators salary schedule; and


BE IT FURTHER RESOLVED, that the Board of Benton County Commissioners retain the right to modify or repeal this determination at their discretion and without prior notification; and

BE IT FURTHER RESOLVED, that this Resolution is not intended nor shall be interpreted as limiting or compromising the County's "at will" employer status.


