Canal Drive, Kennewick, WA 99336, between the hours of 8 a.m. and noon and 1 p.m. and 5 p.m., Monday thru Friday.

Please provide the following information at the time of submittal. If any of the following information is not available we may not be able to process your application.

- 1. A completed application form and applicable non-refundable fee of \$1000.00.** Please be as specific as possible with regard to your shorelines amendment application, you may use an additional sheet, if necessary.
- 2. Plan Change Map:** Prepare a map of the area for which a plan change is sought, clearly indicating the proposed plan change boundaries. The map scale is to be clearly indicated in the lower right-hand corner together with the north arrow and the date of preparation. Major physical features, both natural and man made, lying within or adjacent to the affected area are to be shown (i.e., including but not limited to highways, railroads, rivers, streams, power lines, settlement patterns, schools and other public buildings, etc.) Section, Township, and Range lines are to be shown and identified. If in the shorelines areas please define the existing shorelines area as shown in the existing shorelines master plan and indicated existing environment designation.
- 3. Names and addresses** of the legal owners and applicant signatures need to be on the application. **ALL persons with an ownership interest in the property on which the land use action is proposed must sign the application other than interests exclusively limited to ownership of the parcel's mineral rights.**

An appeal of the determination must be made in writing to the Benton County Planning Department within 14 days from the date of the determination and a public hearing will be scheduled and the appellant will be notified of the date, time, and place. There is no administrative appeal for a determination of non-significance.
